## The Annual Fund, Campaigns and Endowments

The Grammar School's Annual Fund consists of all gifts received within a fiscal year from July 1 through June 30. These gifts can be Unrestricted Gifts and Grants, which can be used by TGS for any purpose; Parent Fundraising, which raises dollars through functions or sales of items; Allocated Grants, which serve a specific purpose; or Allocated Gifts, which are cash gifts given for a specific purpose.

The most visible and significant campaign of the Annual Fund is the Annual Appeal, in which unrestricted gift income is solicited from the entire Grammar School community.

From time to time, a Capital Campaign becomes necessary to raise funds for long-term additions or improvements to maintain the integrity of The Grammar School. From 1993–1998, a capital campaign raised over \$220,000 to purchase and create the Upper School. From 2003–2006, The Future for Our Children NOW campaign raised over \$750,000 for improvements & expansion to existing facilities and an enhanced scholarship endowment. This was an important milestone in the school's history and further enhanced the overall educational experience for generations to come. TGS is about to reach a milestone as the community prepares for the 50th Anniversary of the founding of the School with festivities to start in the fall of 2010.

**Commemorative Gifts** can be made to honor the memory of a teacher, alumnus, parent, colleague or friend. Depending on the wishes of the donor and the value of the gifts, an endowed fund is established or a special, one-time project or program is funded. For more information regarding the establishment of a commemorative gift, please contact the Development Office.

In addition to its Annual Fund, The Grammar School maintains an **Endowment Fund**, which is a pool of assets that is professionally managed and invested to produce a return that can be used to benefit the School. The Board of Trustees' Investment Committee oversees management of the fund. The endowment enables the School to receive income for operating purposes over and above what is raised through tuition and annual giving. Similar to the Annual Fund, the Endowment Fund encompasses gifts that may be restricted or unrestricted in their purpose. The Grammar

School is most appreciative to donors who contribute to the Endowment Fund as it is most beneficial for the long-term financial well-being of the School. TGS currently maintains two endowment funds:

**The General Endowment Fund** supports the annual financial aid budget and board-designated projects.

**Gifts of Cash** are the most convenient way to give. Such gifts are tax deductible and are vital to the support of The Grammar School's Annual, Capital and Endowment Needs. Please make your checks payable to The Grammar School and send them to 69 Hickory Ridge Road South, Putney, VT 05346.

**Securities** are perhaps the best form of assets to use in making a charitable gift. When ownership of a security which would result in a capital gain if it is transferred to The Grammar School, the donor avoids substantial capital gains taxes and also receives a charitable gift tax deduction for the fair market value of security. Your broker can electronically transfer securities to TGS. Please call Deb Gray, Business Manager, at (802) 387-5364 for further information on how to arrange a transfer.

**Bequests** are gifts left through the estate of the donor. Every member of The Grammar School community should have an up-to-date will. We hope you will consider TGS as one of the beneficiaries. Gifts can be outright or established as remainder interest. For more information, please contact an estate planner.

**Life Income Gifts** include charitable remainder trusts, which are established by the donor, and provide both a current deduction and the right to retain some or all of the income from the donated asset. For more information, please contact an estate planner.

**Matching Gifts** may be available through your company, which can double or sometimes triple the amount of your donation. More than 500 companies match gifts to independent schools. The donor receives credit for both the original gifts and the amount of the match. Please contact your employer to find out if they sponsor a Matching Gift program. 🐦
